OpenBlend Microsoft Teams App Privacy Policy

Background

OpenBlend is an employee centric performance management platform designed to support you to be the best version of yourself by enabling your manager and other HR or senior managers to understand your key drivers. Access to the OpenBlend platform is provided by the company or entity that you work for or to which you provide your services (**your employer**).

There are different sections on the OpenBlend platform, some of which your employer will complete and others that you can fill in with information about yourself, that information will then be available for some others, such as your manager, to view.

The OpenBlend Microsoft Teams App provides an additional mechanism for you to receive notifications from the OpenBlend platform, relating to updates by your manager and/or your team members, and about upcoming OpenBlend sessions. You can also submit updates to some of your data via the OpenBlend Microsoft Teams App.

GDPR and data protection laws

Much of the information in the OpenBlend platform is personal data which must be looked after in accordance with applicable data protection laws, including the GDPR. Under GDPR, your employer is the controller and OpenBlend is a processor of your personal data. OpenBlend processes your data on the instruction of your employer in compliance with applicable data protection laws. Your employer is responsible for looking after and managing your personal data and you should read your employer's privacy notice to understand their purposes of processing your personal data, how they look after it and your rights in relation to your personal data.

The OpenBlend Microsoft Teams App shows data from and submits data to the same data store as the main OpenBlend platform. OpenBlend has one set of rules and mechanisms for how data is managed and looked after, the same rules and mechanisms apply both to the main OpenBlend platform and to the OpenBlend Microsoft Teams App.

We have explained below who can see what of your data in the OpenBlend platform.

* "manager connections": If you wish (and if this capability has been enabled by your employer), you can initiate an "OpenBlend session" with a manager in your employer who is not your line manager – this person is your "manager connection". Such sessions are called "connection sessions". During a connection session, your "manager connection" has the same visibility of your data as your manager.
